9 - Public Comment

Herbie West 409 Irving St spoke on the Chicken Ordinance and the Air BNB. Mr. West talked about how the community banded together to help come through this recovery. The sad part is after we get through this we go back to things we don't agree upon or work together. We can solve so many problems if we work together on small things where they don't really require legal regulations or rules. I just want to speak on the chicken Ordinance I have already spoken at the Planning and zoning meeting. I have written a letter to the Board I think Steve was kind enough to send it to each of you. I think in that letter I laid out a good logical commonsense approach as how to handle this. I think it is a far reach for our governing board to take some of our rights away such a simple thing as owning chickens controlled by the size of your lot requiring permits putting heavily weighted fines on things that really seem out of the commonsensical way of dealing with things. Six foot fences, six foot shrubbery, building things only in the back yard 20 foot away. We have dogs that run all over the place and their dog houses are kind of of atrocious and they just waste all over the yard and people don't clean it up but we all seem to love our dogs no matter what the do, or how they look. I saw we were going to have another meeting on November 14th I will be out of town and won't able to be there. Part of the reason I'm here is not for me it's for the community I own property outside the city limits I can have all the Chickens I want and property to build an Air BnB which your trying to push Air BnB's out. So this is not for me on a personal level because I can do all of these things without the city inhibiting me from doing so. I'm here speaking out for the people that aren't aware of what is going on and having their rights taken away because there is a lot of people that don't keep up with things and communications may not be out there. If you need my letter sent back out I will be glad to send it back out. I think it covers a lot of details about both those subjects with a commonsense way of handling it. I just want to urge the Board not to approve the chicken ordinance the way it was presented at the Planning and Zoning Meeting and urge you to make that more public in the terms of verbiage that is going to be in this so all the community can see what is coming about I urge the ones pushing for this ordinance to really to think about how easy it is to just talk to your neighbor about the chickens. I understand about the roosters they are noisy I'm fine with no roosters. If you have a hundred chickens they can smell. I think if you have neighbors that have chickens and they are bothering you just talk to them and work together as neighbors and a community and not build more legal ordinances.

Sam Craig 119 Friendly Circle wanted to talk about the curbside storm pickup and if leaves were being picked up because the contractor that was working his area told him they weren't picking up leaves and wants a clarification on the leaves, and when it was going to be picked up? And communication we were all having difficulty individually and as a town I know Mayor Morgan said you were working on somethings I would ask that communications be one of those because I went by city hall a few times and there was nothing there at the same time my wife runs communications for a website and she was having trouble getting things up on the website. When we started getting some stuff it was a link that we couldn't get to because of no internet or power. I hope that will be included in your process of rethinking of how things are going. I was a city attorney for the city of Shelby representing Cleveland County and a number of municipalities and counties in numerous capacities along the way so I understand you have a tough job to do and appreciate what you do.

City Manager Orr answered his question That group is not picking up leaves but there will be leaves being picked up.

James Hrynyshyn spoke on the Spectrum lines laying all over the ground and hanging low. Would like city to reach out to them before someone catches one and pulls a power pole down.

12 - Outside Resources and Funds

Foothills Regional Commission-FEMA Discussion on TS Helene Relief Information

City Manager Orr spoke on the recovery and how it may take up to two years to recover the funds and infrastructure required to put us back whole. It will require Patients, Diligent and attention to detail which will be frustrating to a lot of people. I will turn it over to Penny and charlotte.

We have been in contact with Steve and Julie since the storm started we aren't FEMA experts but my prior role before coming to the Commission is doing disaster preparedness that was both in New York and here in North Carolina. She went over ways to help with filing for assistance as a town and as an individual. NC emergency management will be the grantee from FEMA then they will send out program delivery managers. That hasn't occurred at all. We are trying to get the original request for public assistance in to FEMA. FEMA is overwhelmed right now as it is NC,SC,FL,TN,GA and VA that they are having to assist. They usually give 30 days to get your request in but that hasn't even been determined yet. Then it is usually a 60 day turnaround time to get all the damage assessments and documentation to get into the the program delivery Manager. They will sent out and work with v'all. This hasn't occurred yet. It's going to be okay every three days something better that has occurred that is a positive thing. Power coming back on in a two week time frame It is doing so much better between the Army Core of Engineers. National Guard, and all the assistance from the power companies across the Country and Canada. It's been very impressive. If we can hang on at first everyone was panicking we were getting calls from all the entities in the Foothills in our council of government for four counties. It's going to be okay. Put your application in and keep all the documentation and document all you can what's public utilities doing, what are you doing. We have FEMA forms we also have incident command forms so if an one has done anything with emergency management there is a lot of Planning, logistic, operation and finance. It's going to take a while to get your reimbursement. If they see you have all the documentation how much overtime they are going to say these folks have it together they will expedite your request, I hope I have explained that on a basic level. There is tip sheets in the binder which you have been doing for the last two weeks. Get your stuff into your insurance FEMA isn't going to reimburse double. Insurance won't pay for overtime, police and supplies so get that into FEMA for the 1st two weeks as long as it's for emergency as long as it documented for hazardous prevention, safety, public health all of that. There is more in the binder there is a small business association, USDA farm and algaculture information in there as well. The bottom line is keep documenting while we wait for them to give us a program delivery manager. I urge you to go on line and put in for your individual assistance and the town for public assistance. I will be talking to Steve about that a little bit down the road on to help you get some funding for future preparedness. For anyone else On October 23rd from 4 to 6 it will be at ICC in Spindale will be a representative there out of DC that is our Western region area.

Commissioner Marion I have two questions how are Air BnB and short term rentals how is that look at would it be a second home or a business what if it was in a LLC. And would it be beneficial to go to the meeting at ICC?

If it a business it will be different. As far as Air BnB I will look into that I don't want to give you the wrong information. I would say it would be a second home it ask on the applications if this is your primary home or secondary home. There is so many pieces. It's worth putting in for. Yes go to the meeting.

Commissioner Marion I heard today that the 750.00 is a loan and you will have to pay it back

City Manager Orr went over

- -Claims Filed for Storm Damage to City Property and Facilities to NCLM
- -Good of the City to the Police Department, City Maintenance Personnel, Volunteers, City Staff, BOC

We are dealing with an issue with our pump system down on Hwy 176 both pumps are down. They were damaged in the storm one pump is in Greenville being repaired. We are working off the pressure off the Hendersonville line which is keeping the tank full with pressure. Judds peak is getting water because the have power and the small pump is working. Our waste water treatment plant is operational we had a little issue with trees falling on the bar screen we have had some control Pannel issues we have an electrician coming tomorrow because of the power surges and loss of power so we will repairs at the waste water treatment plant. We know there are issues on roads and streets that will have to be dealt with. We are trying to get basic services straightened out before we address some of the road situation. We have had on Chisolm street a wet weather spring that hasn't been active for years which created a soft spot that we had to dig out and put in a French drain system. We are dealing with some other issues like drainage the storm water management we will continue to get debris. They are picking up and grinding the leafy debris we will come back around with Chris Bradley's vacuum and pick up the leaves. GFL starts tomorrow coming around picking up storm damage that can be white goods, construction debris, carpets, any of those things that was damaged by flooding or a tree hitting the home. It has to be within 10 feet of the curb side. We sent out the FEMA documentation as what we can accept. We hope that will help people out. The county is going to help pick up leafy debris on most state roads. Tonight Jana is going to be working with us on a inter local agreement that polk county is going to be arriving with that I don't know the time frame I hope Jana can help us with that. I will answer any questions that I can answer we normally don't do this but I will answer if I can.

A gentleman in the audience asked if the water tank issue could mean a water distribution issue for the town. City manager orr No because it is elevated and receives pressure and stays ¾ full.

A lady asked they will be taking construction material?

City Manager Orr, Yes they have a grapple hook on the truck and will pick it up.

Assistant City Manager & Finance Officer Julie Osteen according to GFL they will make two passes around one for debris and one for White goods.

City Manager Orr we also have good of the city the police department, our city Maintenace personal for the incredible amount of over time. We had a lot of volunteers, our city staff and our board of commissioners. I want to mention Tim Anderson and Shane Varnadore deserve a lot of your kudos when you see them. Those two guys are two local contractors we rely on they helped getting things opened up fairly quickly let them know they did a phenomenal job they did some dangerous work to get things opened up.

I'm happy to advise you that we have received the initial bid on the .23 acres submitted by Mr. & Mrs. Williams has been accepted we didn't receive any further bids. I have advised the attorney for williams that their bid has been accepted. We are going to close on the .10 and the .23 acer not sure of the closing date yet.

18 - Local Emergency Ordinance / Proclamation of a City of Saluda State of Emergency

Jana went over the draft local emergency Ordinance of what happens when there is a state of emergency it explains what happens when there is an emergency who declares the state of emergency, purchases are made and thing of that nature. The chain of command is with respect of declaration of state of emergency is the Mayor, in the event the Mayor is not here then the mayor pro tem if neither of those two are available then it goes to the full board of commissioners to do the declaration of state of emergency. There are limited powers some of those are to prohibit the sale of alcohol, to put in a curfew and when people can be out and things of that nature. Those are the powers that the Mayor has, the Mayor Pro Tem and the Board of Commissioners. This is pretty much what everyone else does. The powers are written in the statues and they do list all the powers that you do have.

Commissioner Walker read a part that said a in the absent of the Mayor and the Mayor pro Tem a quorum of the board of commissioners must be present so how many would that be we only have three left.

Attorney Berg a majority so all three Commissioners would have to be Present.

Commissioner oxtoby made a motion to approve the Local Emergency Ordinance as written Commissioner Talbot seconded all were in favor.

Martin Anderson Spoke in Reference to the Pace Park Art Mural Description of all the wonderful people it will be 64x16 we went over how to describe these six people that helped to define Saluda History Dr. D. Lesesne Smith, Lola Ward, Charlie Ward, Phoebia Sullivan, Robert Pace and William "Billy" Morris. We were asking the city to cover they cost \$212.96 but Bruce James and his wife Sara have offered to pay for said sign which is very gracious and wonderful. We still ask the city to give permission to have the sign posted. Whenever it is convenient to the city to do so. It would require the small pace park sign to be moved.

Commissioner Marion made a motion to approve the permission of putting up the sign 64 x 16 Commissioner Talbot seconded all were in favor.

21 - Inter-local Agreement with Polk County, NC for Vegetative Storm Debris Removal

Attorney Berg went over the Inter-Local Agreement for Vegetative storm debris removal the county through the states Emergency Management division is piggy backing onto a state contract for debris removal and monitoring of debris removal. The state issued a invitation for bids back in 2019 two contractors we successful bidders for our region which is region 12 then it goes westward from here the county has issued a notice to proceeded to those two contractors so I presume they are doing what they need to do to get prepared to start hauling out debris. I assume

that the county will let the townships know the dates to have the debris ready for pick up. This has been a fast evolving process this evening right before I came here I was advised that you have in your packet from the FEMA people it in respect to the US Army Core of Engineers doing some debris pickup so rather than paying for debris removal then applying for reimbursement the US Army Core of Engineers doing it their selves. There's no need to pass through. I don't know if this is going to supplant the contracts that are in effect or in addition to or how that works just yet how ever I prepared where the city of Saluda is giving the County permission to operate in the city limits that would be the two contractors I put in a copy of the two contracts for you to review they are lengthy, they are state contracts and you can't do anything to modify them. In light of the fact that the Army Core of Engineers may undertake some of the effort I have proposed some modification to it. This came to me after five today I do have some proposed language if you will look at the letter dated October 9th signed by Steve Orr what I propose to change about that letter is for the seconded paragraph substitute this in addition we further understand Polk County is presently working with the US Army Core of Engineers to enable Polk County to become one of the beneficiaries of a contract issued by US Army Core of Engineers for additional debris removal services. New paragraph please accept this letter as conformation as the City authorizing Polk Counties contractor and should Polk County become a beneficiary of the US Army Core of Engineers contract for additional debris removal service, for the US Army Core of Engineers contractor to operate within the Cities corporate limits. Then it goes one to say that I will be the point of contact for the city regarding these contracts. Please advise of any additional coordination or assistance that may be

the City. So I modified that a little bit to include the US Army Core of Engineers where if that comes to tuition you have expressively granted them permission to preform debris removal services in the city without a need for a pass through less paperwork.

Assistant City Manager & Finance Officer Julie Osteen said that she has also reached out Henderson county to for their Henderson County residents.

Commissioner Marion made a motion to approve the Inter-Local Agreement as presented with the changes that were made during the meeting Commissioner Walker seconded all were in favor.
